 - If coach isn't vaccinated and they intend to go the negative test route, they need to let us know or they won't be rostered
 - v. Decision leave as is, and let coaches know that it is within their discretion to add on ice helpers in Coaldale that aren't vaccinated or willing to provide a test - as this is all that is required without having REP in place. We will leave as is until we need to adjust due to changing restrictions / requirements
