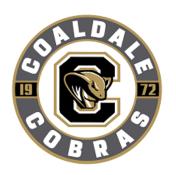
Coaldale Minor Hockey Association Board Meeting – Meeting Minutes Coaldale Sportsplex November 12, 2024 7:00pm
